**From Nebraska State Statue 2-1213**

A mare must have been continuously in the State of Nebraska for **90 days prior to foaling** except that this period may be reduced in days by the following situation:

Mares in foal purchased at a nationally recognized thoroughbred or quarter horse blood stock sale, the name and pedigree of the mare being listed in the sale catalog, and which is brought into this state and remains in this state **30 days immediately prior to foaling**.

NOTE: Mares purchased at private treaty must meet the **90-day requirement**.
